The structure of our Governing Body

The **Full Governing Body** oversees matters relating to all aspects of the school, overseeing the strategic leadership and accountability. It has three key functions:

- Overseeing the financial performance of the school and making sure its money is well spent;
- Holding the head teacher to account for the educational performance of the school and its pupils;
- Ensuring clarity of vision, ethos and strategic direction.

The **Teaching and Learning Committee** oversees matters relating to teaching and learning. This includes curriculum, academic performance within the school and pupil matters such as admissions, behaviour and safety, moral and cultural development. The Committee also looks at those staffing matters which relate to the achievement of pupils, quality of teaching and leadership and management.

The **Resources Committee** oversees matters relating to the financial management of the school along with personnel and premises issues. It also considers pay matters at an aggregate level with more sensitive individual pay decisions taken by the smaller staff salaries committee.

In addition to the two main committees there are also:

- **Headteacher Appraisal Panel/ Headteacher and Staff Salaries Panel**
This committee comprises the Chair of Governors and the Committee Chairs (Teaching and Learning and Resources). In the event that one of the two Committee Chairs is a parent governor they will be replaced by a third governor.
- **Second stage Grievances/ Appeals Panel**

Pupil Exclusions Panel

The Discipline/Appeals committees are to be constituted as required from those governors who are neither staff nor parents who may be conflicted.

The Governing Body also establishes Working Parties when needed to take on specific tasks under a time specified period.
